

Thence South $00^{\circ}51'03''$ West along the West line of said northwest quarter a distance of 2230.32 feet;

Thence North $90^{\circ}00'00''$ West for a distance of 54.28 feet to a point on the centerline of United States Forest Service 25 Road, said point also being the Northwest corner of the "Loowit Short Plat", as recorded under Auditor's File number 2006160728, records of Skamania County, Washington;

Thence along the North line of said "Loowit Short Plat", North $74^{\circ}32'46''$ East for a distance of 125.00 feet;

Thence along the arc of a 145.51 foot radius, tangent curve to the right, for an arc distance of 80.00 feet, through a central angle of $31^{\circ}30'00''$, the long chord of which bears South $89^{\circ}42'14''$ East for a chord distance of 78.99 feet.

Thence North $90^{\circ}00'00''$ East for a distance of 1025.00 feet to the TRUE POINT OF BEGINNING;

Thence North $02^{\circ}51'59''$ West for a distance of 712.97 feet;

Thence along the arc of a 500.00 foot radius, tangent curve to the left, for an arc distance of 79.57 feet, through a central angle of $09^{\circ}07'04''$, the radius of which bears South $87^{\circ}08'01''$ West, the long chord of which bears North $07^{\circ}25'31''$ West for a chord distance of 79.48 feet;

Thence North $11^{\circ}59'03''$ West for a distance of 131.36 feet;

Thence North $90^{\circ}00'00''$ East for a distance of 1021.13 feet;

Thence South $12^{\circ}11'34''$ West for a distance of 1125.20 feet;

Thence North $75^{\circ}44'48''$ West for a distance of 732.85 feet to the TRUE POINT OF BEGINNING.
