

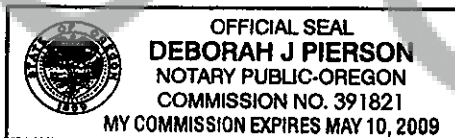

A tract of land located in a portion of the Northwest quarter of Section 30, Township 7 North, Range 6 East, Willamette Meridian, Skamania County, Washington, more particularly described as follows;

Beginning at the Northwest corner of said Northwest quarter of said Section 30;

Thence South $00^{\circ}17'48''$ East along the West line of said Northwest quarter for a distance of 916.00 feet to the TRUE POINT OF BEGINNING;

Thence North $88^{\circ}42'49''$ East for a distance of 242.28 feet;

Thence North $66^{\circ}53'54''$ East for a distance of 343.59' feet;

Thence along the arc of a 143.10 foot radius, non-tangent curve to the right, for an arc distance of 45.05 feet, through a central angle of $18^{\circ}02'20''$, the radius of which bears North $74^{\circ}30'49''$ West, the long chord of which bears South $24^{\circ}30'21''$ West for a chord distance of 44.87 feet;

Thence along the arc of a 182.54 foot radius, reverse curve to the left, for an arc distance of 113.89 feet, through a central angle of $35^{\circ}44'46''$, the radius of which bears South $56^{\circ}28'29''$ East, the long chord of which bears South $15^{\circ}39'08''$ West for a chord distance of 112.05 feet;

Thence South $02^{\circ}13'15''$ East for a distance of 155.95 feet;

Thence South $06^{\circ}45'05''$ East for a distance of 37.09 feet; NH

Thence along the arc of a 104.05 foot radius, non-tangent curve to the left, for an arc distance of 101.35 feet, through a central angle of $55^{\circ}48'33''$, the radius of which bears North $22^{\circ}44'11''$ East, the long chord of which bears North $84^{\circ}49'54''$ East for a chord distance of 97.40 feet;

Thence along the arc of a 316.93 foot radius, reverse curve to the right, for an arc distance of 153.62 feet, through a central angle of $27^{\circ}46'17''$, the radius of which bears South $33^{\circ}04'22''$ East, the long chord of which bears North $70^{\circ}48'47''$ East for a chord distance of 152.12 feet;

Thence along the arc of a 1265.58 foot radius, compound curve to the right, for an arc distance of 191.14 feet, through a central angle of $08^{\circ}39'12''$, the radius of which bears South $05^{\circ}18'05''$ East, the long chord of which bears North $89^{\circ}01'31''$ East for a chord distance of 190.96 feet;

Thence along the arc of a 194.32 foot radius, reverse curve to the left, for an arc distance of 96.33 feet, through a central angle of $28^{\circ}24'09''$, the radius of which bears North $03^{\circ}21'07''$ East, the long chord of which bears North $79^{\circ}09'02''$ East for a chord distance of 95.35 feet;

Thence North $64^{\circ}56'58''$ East for a distance of 140.10 feet;

Thence North $70^{\circ}12'11''$ East for a distance of 81.76 feet;

Thence South $00^{\circ}12'07''$ West for a distance of 463.91 feet;

Thence South $64^{\circ}40'51''$ West for a distance of 191.60 feet;

Thence along the arc of a 339.05 foot radius, tangent curve to the left, for an arc distance of 104.05 feet, through a central angle of $17^{\circ}35'00''$, the radius of which bears South $25^{\circ}19'09''$ East, the long chord of which bears South $55^{\circ}53'21''$ West for a chord distance of 103.64 feet;

Thence along the arc of a 226.82 foot radius, non-tangent curve to the right, for an arc distance of 211.07 feet, through a central angle of $53^{\circ}19'05''$, the radius of which bears North $42^{\circ}38'26''$ West, the long chord of which bears South $74^{\circ}01'06''$ West for a chord distance of 203.54 feet;

Thence along the arc of a 260.57 foot radius, reverse curve to the left, for an arc distance of 183.57 feet, through a central angle of $40^{\circ}21'53''$, the radius of which bears South $10^{\circ}40'39''$ West, the long chord of which bears South $80^{\circ}29'43''$ West for a chord distance of 179.80 feet;

Thence South $60^{\circ}18'46''$ West for a distance of 701.85 feet to a point on said west line of the Northwest quarter; NH

Thence North 00°17'48" West along said west line, for a distance of 1071.47 feet
to the TRUE POINT OF BEGINNING.
