Thence North $69^{\circ}47'15''$ West for a distance of 108.50 feet;

Thence along the arc of a 50.65 foot radius, non-tangent curve to the left, for an arc distance of 48.46 foot radius, through a central angle of $54^{\circ}49'06''$, the radius of which bears South $16^{\circ}11'48''$ West, the long chord of which bears South $78^{\circ}47'15''$ West for a chord distance of 46.63 feet;

Thence along the arc of a 141.50 foot radius, reverse curve to the right, for an arc distance of 71.22 foot radius, through a central angle of $28^{\circ}50'16''$, the radius of which bears North $38^{\circ}37'18''$ West, the long chord of which bears South $65^{\circ}47'51''$ West for a chord distance of 70.47 feet;

Thence South $80^{\circ}12'59''$ West for a distance of 66.15 feet;

Thence North $09^{\circ}47'01''$ West for a distance of 30.00 feet;

Thence along the arc of a 1332.20 foot radius, non-tangent curve to the left, for an arc distance of 416.67 foot radius, through a central angle of $17^{\circ}55'13''$, the radius of which bears South $11^{\circ}25'06''$ East, the long chord of which bears South $69^{\circ}37'17''$ West for a chord distance of 414.97 feet;

Thence along the arc of a 171.42 foot radius, reverse curve to the right, for an arc distance of 181.69 foot radius, through a central angle of $60^{\circ}43'37''$, the radius of which bears North $29^{\circ}20'19''$ West, the long chord of which bears North $88^{\circ}58'31''$ West for a chord distance of 173.30 feet;

Thence North $58^{\circ}36'42''$ West for a distance of 87.46 feet;

Thence along the arc of a 247.67 foot radius, non-tangent curve to the left, for an arc distance of 142.89 foot radius, through a central angle of $33^{\circ}03'19''$, the radius of which bears South $34^{\circ}02'32''$ West, the long chord of which bears North $72^{\circ}29'07''$ West for a chord distance of 140.91 feet;

Thence North $89^{\circ}00'47''$ West for a distance of 91.17 feet;

Thence along the arc of a 727.30 foot radius, non-tangent curve to the left, for an arc distance of 177.73 foot radius, through a central angle of $14^{\circ}00'06''$, the radius of which bears South $05^{\circ}47'43''$ East, the long chord of which bears South $77^{\circ}12'14''$ West for a chord distance of 177.29 feet;

Thence South $70^{\circ}12'11''$ West for a distance of 218.53 feet;

Thence South $64^{\circ}56'58''$ West for a distance of 140.10 feet;

Thence along the arc of a 194.32 foot radius, tangent curve to the right, for an arc distance of 96.33 foot radius, through a central angle of $28^{\circ}24'09''$, the radius of which bears North $25^{\circ}03'02''$ West, the long chord of which bears South $79^{\circ}09'02''$ West for a chord distance of 95.35 feet;

Thence along the arc of a 1265.58 foot radius, reverse curve to the left, for an arc distance of 191.14 foot radius, through a central angle of $08^{\circ}39'12''$, the radius of which bears South $03^{\circ}21'07''$ West, the long chord of which bears South $89^{\circ}01'31''$ West for a chord distance of 190.96 feet;

Thence along the arc of a 316.93 foot radius, compound curve to the left, for an arc distance of 153.62 foot radius, through a central angle of $27^{\circ}46'17''$, the radius of which bears South $05^{\circ}18'05''$ East, the long chord of which bears South $70^{\circ}48'47''$ West for a chord distance of 152.12 feet;

Thence along the arc of a 104.05 foot radius, reverse curve to the right, for an arc distance of 101.35 foot radius, through a central angle of $55^{\circ}48'33''$, the radius of which bears North $33^{\circ}04'22''$ West, the long chord of which bears South $84^{\circ}49'54''$ West for a chord distance of 97.40 feet;

Thence North $06^{\circ}45'05''$ West for a distance of 37.09 feet;

Thence North $02^{\circ}13'15''$ West for a distance of 155.95 feet;

Thence along the arc of a 182.55 foot radius, tangent curve to the right, for an arc distance of 113.89 foot radius, through a central angle of $35^{\circ}44'46''$, the radius of which bears North $87^{\circ}46'45''$ East, the long chord of which bears North $15^{\circ}39'08''$ East for a chord distance of 112.05 feet;

Thence along the arc of a 143.10 foot radius, reverse curve to the left, for an arc distance of 45.05 foot radius, through a central angle of $18^{\circ}02'20''$, the radius of which bears North $56^{\circ}28'29''$ West, the long chord of which bears North $24^{\circ}30'21''$ East for a chord distance of 44.87 feet;

Thence North $66^{\circ}53'54''$ East for a distance of 17.14 feet;

Thence North $63^{\circ}02'06''$ East for a distance of 256.41 feet;

Thence North $45^{\circ}01'08''$ East for a distance of 128.54 feet;

Thence North $60^{\circ}57'42''$ East for a distance of 77.08 feet;

Thence North $56^{\circ}34'34''$ East for a distance of 347.72 feet to the TRUE POINT OF BEGINNING.
