Parcel 1





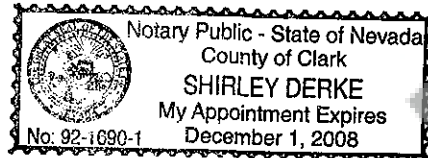
