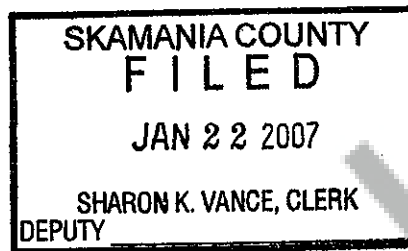

11 now, therefore, it is hereby


12 ORDERED, ADJUDGED and DECREED that the defendants are in default. It is
