

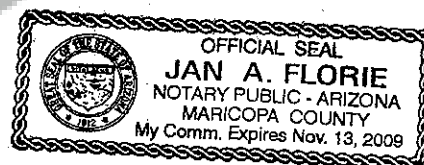

LEGAL DESCRIPTION

A tract of land in the Southeast Quarter of Section 25, Township 3 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Lot 2 of the Davison Short Plat recorded in Book 3 of Short Plats, Page 300, Skamania County Records.

Together with an easement for access over Lot 1 of the Short Plat recorded in Book 3 of Short Plats, Page 300 as follows:

Easement shall consist of all the land between points on the South and Western boundary on Lot 1; these points measure from the Southwest corner of Lot 1, 17 Feet North to 41 feet North along the Western Boundary line of Lot 1 and 15 feet East to 34 feet East along the Southern Boundary line of Lot 1; this easement is named Jamcatts Road and shall only be used to access Lot #2; as recorded in Book 200, Page 404.
