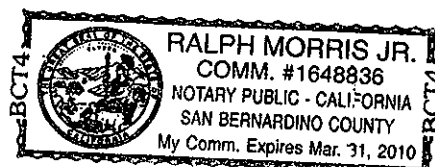


Exhibit A

A tract of land in the Northwest quarter of the Northeast quarter of Section 10, Township 1 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a point on the Northerly right of way line of Primary State Highway No. 14, as the same is established and traveled July 1, 1978, which is 200 feet West of the East line of the Northwest quarter of the Northeast quarter; thence continue along said North right of way line to a point that is 475 feet West of the East line of said Northwest quarter of the Northeast quarter; thence North parallel with the East line to a point on the Southerly right of way line of State Road No. 140, known as Krogstead Road, as the same is established and traveled July 1, 1978; thence along said Southerly right of way line to a point that is 200 feet West and parallel to the East line of the Northwest quarter of the Northeast quarter; thence South parallel to and 200 feet distant from the East line of the Northwest quarter of the Northeast quarter to the Point of Beginning.
