EXHIBIT "A"

That portion of the Northeast Quarter of Section 11, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at a point on the North boundary of the North Bank Highway right of way which is South $85^{\circ} 52'$ West 195.5 feet from the Northwest corner of the property owned in the year 1923 by School District 9; thence North $38^{\circ} 03'$ West 116 feet along the Old Gunther-Gattanini Road; thence North $08^{\circ} 01'$ West 150 feet; thence South $81^{\circ} 59'$ West 200 feet; thence South $16^{\circ} 21'$ East along a creek at a distance of 6 feet from the center of said creek a distance of 100 feet; thence south $32^{\circ} 01'$ East continuing along the aforesaid creek 6 feet from its center for a distance of 166 feet to the North boundary of the North Bank Highway right of way; thence North $83^{\circ} 29'$ East along said North right of way 170 feet to the point of beginning.
