## NOTICE OF CLAIM FOR DAMAGES Addendum

This is a claim for damages pursuant to RCW 4.96 and presented against the County of Skamania, acting by and through the Skamania County Parks and Recreation Department, and/or its agents and/or employees, including but not limited to, the office of public works director, the office of community events and recreation director and the office of building and grounds director. The claimant submits the following claim under penalty of perjury in accordance with the laws of the State of Washington.

The claimant is Ms. Sherry D. Henderson. At the current time, and for six months prior to the claim arising, claimant resided at 3771 Cook Underwood Road, Cook, Washington, 98605.

The circumstances which brought about the injuries for which this claim is being filed occurred on or about August 17, 2005 at approximately 11:00 p.m., near the Drano Lake county park and boat ramp near Stevenson, Skamania County Washington.

On the above date and approximate time, Ms. Henderson tripped and fell over a boulder after exiting the restroom facility near the Drano Lake boat ramp. The boulder had been cemented into the concrete walking area that is adjacent to the restroom door. It was dark at the time of the fall and Ms. Henderson was unaware that the walking pathway from the restroom was obstructed by the boulder. The boulder was not in Ms. Henderson's line of vision and there was no warning or proper lighting at the time of the fall. See Exhibit A.

The County of Skamania, acting by and through the Skamania County Parks and Recreation Department, and/or its agents and/or employees has a duty to exercise reasonable care in the maintenance and operation of the Drano Lake county park and boat ramp.

With regard to the incident, the County of Skamania, acting by and through the Skamania County Parks and Recreation Department, and/or its agents and/or employees failed to fulfill its duty of care to Ms. Henderson thereby cause server and permanent bodily injury. The injuries and damages suffered include:

Sherry D. Henderson: Severe, physical injuries, including but not limited to, damage to Ms. Henderson's shoulder, rotator cuff, emotional distress, loss of income, medical expenses.




