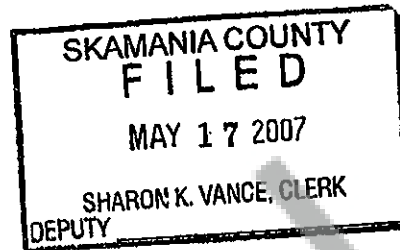

18 fees of \$750.00, for a total judgment


