The undersigned subordinator and owner agrees as follows:

- Riverview Community Bank, referred to herein as "subordinator", is the owner and holder of a mortgage dated <u>December 24, 2001</u>, which mortgage is duly recorded on <u>December 26, 2001</u> under Auditor's File No. <u>143266</u>, records of <u>Skamania County</u>.
- 2. Riverview Community Bank referred to herein as "lender", is the owner and holder of a mortgage dated 7-1/-07, executed by Donald S. McAndie & Pamela McAndie (which is recorded on 8-8-07, in Volume of Mortgages, Page, under Auditor's file number 2007/67189, records of County) (which is to be recorded concurrently herewith).
- Donald S McAndie and Pamela McAndie referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in paragraph 2.
- 4.
