The Planning Department issued an Administrative Decision on April 12, 2006 and a Letter Amendment on February 22, 2007 for the above referenced application. On August 21, 2007 we received a letter from you requesting a second amendment to slightly modify the original application to change the footprint of the

approved single-family dwelling from 32'x24' to 40'x25', and slightly modifying the design (see attached elevation drawings).




