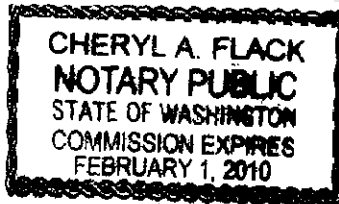


Exhibit A
