

COMMENCING at a point on the East line of the Southwest quarter of the Southeast quarter of Section 26, Township 2 North, Range 6 East of the Willamette Meridian, Skamania County, Washington, which point is 493 feet North of the South 16th corner of said Southeast quarter; thence North  $81^{\circ}13'$  West 75 feet, more or less, to the extension Southerly of the East line of that parcel of land deeded to Gary R. Hains, et ux, by deed recorded December 5, 1985, in Book 85, page 358; thence North  $02^{\circ}45'$  West 305 feet to the Northeast corner of said Hains parcel; thence North  $81^{\circ}13'$  West 787 feet, more or less, to a point which bears South  $25^{\circ}14'$  West from the Northeast corner of the Northwest quarter of the Southeast quarter of said Section 26; thence North  $25^{\circ}14'$  East to the intersection with the North line of the Southeast quarter of said Section 26; thence East along the said North line to the Northwest corner of that parcel deeded to James A. Kallas, et ux, by deed recorded March 29, 1979, in Book 76, page 323; thence South  $06^{\circ}23'$  East along the West line of said Kallas parcel to the Northeast corner of that parcel deeded to Ernest C.
