

LEGAL DESCRIPTION FOR THREE RIVERS RECREATIONAL AREA

RECONFIGURED LOT 4 OF "PINE TREE SHORT PLAT" (1.4 ACRES):

A portion of the South half of the Northeast quarter of Section 23, Township 7 North, Range 6 East, Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a concrete monument at the Northeast corner of Section 23; thence South 01° 18′ 16″ West, along the East line of Section 23, for a distance of 1655.91 feet; thence North 89° 20′ 18″ West, 132.07 feet to the Northeast corner of Lot 4 of the "Pine Tree Short Plat", as shown in Skamania County Auditor's File No. 2004159232 and the TRUE POINT OF BEGINNING; thence following the centerline of Lodgepole Lane, southerly, along the arc of a 1500 foot radius curve to the right, (the radial bearing of which is South 89° 31′ 56″ West) through a central angle of 06° 21′ 30″, for an arc distance of 166.46 feet to the Northeast corner of Lot 3 of the "Pine Tree Short Plat"; thence North 89° 22′ 46″ West, 367 feet, more or less, to the Northwest corner of Lot 3 at a point in the center of Pine Creek; thence Northerly, along the center of Pine Creek, 167 feet, more or less, to the North line of Lot 4 of the "Pine Tree Short Plat"; thence South 89° 20′ 18″ East, 362 feet, more or less, to the TRUE POINT OF BEGINNING.
