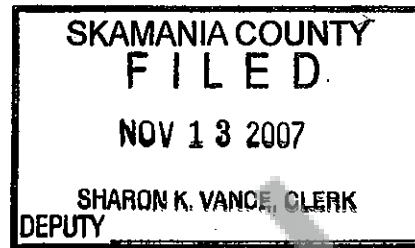

It is further


