WITNESSETH:

That whereas it is the desire, purpose and intention of JOSEPH E. LINGO and KATHERINE A. LINGO, husband and wife, to jointly enter into an agreement concerning the disposition of the whole of the community property, wheresoever situated, now owned or hereafter at anytime acquired by them, to take effect upon the death of either of them, whereby all of the said property shall pass without delay or expense at the death of either to the survivor of either.
