DECLARATION OF COVENANT

I the undersigned owner in fee simple of the land described herein, hereby declare this covenant and place same on record.

I the grantor herein, am the owner in fee simple of the following described real estate situated in Skamania County, State of Washington; to wit:

The North Half of Lot 1 of Block 15 of the MANZANOLA ORCHARDS AND LAND COMPANY TRACTS, according to the official Plat thereof, on file and of record at Page 37 of Book 'A' of Plats, records of Skamania County, Washington, said real property being also described as: The North Half of the Northeast Quarter of the Northwest Quarter at the Northeast Quarter of Section 15, Township 3 North, Range 9 East of the Willamette Meridian, in the County of Skamania, State of Washington.

on which the grantor owns and operates a well and waterworks supplying for public use located on said real estate, at: (171 Bush Road Cook WA. 98605) and,

The North Half of Lot 1 of Block 15 of the MANZANOLA ORCHARDS AND LAND COMPANY TRACTS, according to the official Plat thereof, on file and of record at Page 37 of Book 'A' of Plats, records of Skamania County, Washington, said real property being also described as: The North Half of the Northeast Quarter of the Northwest

Quarter at the Northeast Quarter of Section 15, Township 3 North, Range 9 East of the Willamette Meridian, in the County of Skamania, State of Washington.

and grantor is required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said grantor water supply.

NOW, THEREFORE, the grantor agrees and covenants that said grantor, his heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the grantor and within 100 (one hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination such as septic tanks and drain fields, sewer lines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.



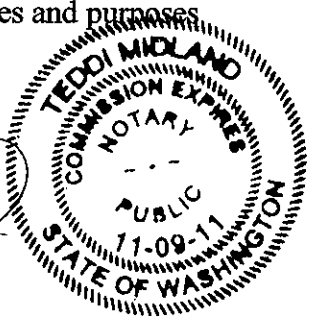
