

I. Identification of Claimants

1.1 Claimants are as follows: Beth E. Pinson, as Guardian of the person and Estate of Krysta Necole Pinson; Britton T. Pinson, individually, and as father of Krysta Necole Pinson; and Beth E. Pinson, individually, and as mother of Krysta Necole Pinson.

1.2 Krysta Necole Pinson is a minor; her date of birth is November 29, 1994. Krysta Necole Pinson resides with her parents, Britton T. Pinson and Beth E. Pinson. Krysta Necole Pinson's father is Britton T. Pinson, and her mother is Beth E. Pinson. The actual residence of Krysta Necole Pinson, Britton T. Pinson, and Beth E. Pinson is 1000 NE 65<sup>th</sup> Street, Vancouver, Washington 98665. This has been Krysta Necole Pinson, Britton T. Pinson, and Beth E. Pinson's residence since March, 2005. Further, 1000 NE 65<sup>th</sup> Street, Vancouver, Washington, 98665 was the actual residence of Krysta Necole Pinson, Beth E. Pinson, and Britton T. Pinson for a period of six months immediately prior to the time this claim arose, which was October 10<sup>th</sup>, 2005.

1 1.3 Krysta Necole Pinson's mother, Beth E. Pinson, was  
2 appointed as Guardian of the person and Estate of  
3 Krysta Necole Pinson on October 27, 2006, in Clark  
4 County Superior Court.

## 6 II. Identification of Respondents

7 2.1 The respondent is Skamania County, a County located in  
8 the State of Washington. Skamania County owns property  
9 at 17051 Washougal River Road, Washougal, Washington,  
10 98671. This camp is known as "Camp WA-RI-KI", and also  
11 known as "Camp WI-RI-KI", (hereafter referred to as  
12 "Camp WA-RI-KI") located in Skamania County,  
13 Washington, at 17051 Washougal River Road, Washougal,  
14 Washington, 98671. The Skamania County parcel number is  
15 02050000020100. This parcel is the subject of this  
16 Tort Claim Notice, and further is the property  
17 whereupon Krysta Necole Pinson suffered injuries.

## 20 III. Facts of the Incident

21 3.1 On or about October 10<sup>th</sup>, 2005, in Skamania County,  
22 Washington, Image Elementary School hosted an overnight  
23 school camp. This camp facility is known as "Camp WA-  
24  
25

1 RI-KI", and is located in Skamania County, at 17051  
2 Washougal River Road, Washougal, Washington, 98671.

3  
4 3.2 On or about October 10<sup>th</sup>, 2005, Krysta Necole Pinson was  
5 a student at Image Elementary School in the Evergreen  
6 School District and attended the overnight camp at Camp  
7 WA-RI-KI, located in Skamania County, Washington.

8  
9 3.3 On or about October 10<sup>th</sup>, 2005, at Camp WA-RI-KI, Krysta  
10 Necole Pinson was participating in an overnight camp  
11 with her elementary school. The children were  
12 instructed to bring a sleeping bag and a pillow for  
13 sleeping.

14  
15 3.4 On or about October 10, 2005, Camp WA-RI-KI had bunk  
16 beds (two high, an upper bunk over a lower bunk) for  
17 the children to sleep upon. The mattresses of the bunk  
18 beds are covered with a plastic material. The plastic  
19 material used to cover the mattresses created a slick  
20 surface. The bed railings on the bunks were of  
21 insufficient height, length, and/or design to protect  
22 against a person sliding and/or falling off of the bunk  
23 beds.

2 3.5 On or about October 10<sup>th</sup>, 2005, Krysta Necole Pinson was  
3 sleeping on a bunk with the above-described plastic  
4 material covering the mattress at Camp WA-RI-KI.

5 Krysta Necole Pinson's sleeping bag slipped off of the  
6 top bunk in the middle of the night. Krysta Necole  
7 Pinson fell approximately four feet down to the  
8 concrete floor, landing on her head. Krysta Necole  
9 Pinson was knocked unconscious and suffered injuries.  
10

11  
12 3.6 Krysta Necole Pinson was awakened by an Evergreen  
13 School District Staff Member who told her she had  
14 fallen off the bed. Krysta Necole Pinson was  
15 instructed to go back to bed. Krysta Necole Pinson  
16 awoke later that night and reportedly felt that she was  
17 unable to move her extremities.  
18

19 **IV. Injuries**

20 4.1 Beth E. Pinson received a call at work on October 11,  
21 2005. She learned that Krysta Necole Pinson was  
22 injured. Beth E. Pinson contacted Mr. Ivan Beer and  
23 Mrs. Loydene Beer, Krysta Necole Pinson's Grandfather  
24 and Grandmother. Beth E. Pinson asked Ivan and Loydene

1 to go pick Krysta Necole Pinson up from Camp WA-RI-KI  
2 and take her home. Mr. Ivan Beer and Mrs. Loydene  
3 Beer are both residents of Clark County.  
4

5 4.2 Krysta Necole Pinson's mother, Beth E. Pinson, called  
6 the Kaiser Permanente Advice line. A representative of  
7 Kaiser contacted Krysta Necole Pinson's grandparents  
8 directly by phone and instructed them to take Krysta  
9 Necole Pinson to the Emergency Room Department at  
10 Southwest Washington Medical Center, which they did.  
11

12  
13 4.3 At Southwest Washington Medical Center, Krysta Necole  
14 Pinson was treated by Dr. Peter Stich, M.D., who  
15 diagnosed her with a Occipital Skull Fracture and  
16 internal head injuries.  
17

18 4.4 Krysta Necole Pinson was transported by ambulance to  
19 Doernbecher Children's Hospital in Portland, Oregon on  
20 October 11, 2005.  
21

22 4.5 Krysta Necole Pinson arrived at Doernbecher Children's  
23 Hospital and was evaluated by Dr. Ritu Sahni, M.D. Dr.  
24 Sahni diagnosed Krysta Necole Pinson with extra-axial

1 bleeding with right occipital skull basal fracture.  
2 Krysta Necole Pinson was admitted to Intensive Care  
3 unit for clinical observation. Krysta Necole Pinson  
4 stayed at Doernbecher Children's Hospital until October  
5 12, 2005. Krysta Necole Pinson was discharged with a  
6 school note and special instructions limiting her  
7 activities.  
8

9  
10 4.6 Krysta Necole Pinson incurred medical bills in the  
11 amount of \$16,896.06, as a proximate result of the  
12 injuries sustained at the outdoor camp at Camp WA-RI-  
13 KI, as earlier set out in this Tort Claim Notice.  
14

#### 15 16 V. Liability

17 5.1 That at the time and place of the above-described fall  
18 off of the bed, Respondent, Skamania County, was  
19 negligent and/or liable in one or more of the following  
20 ways:  
21

- 22 a. Failing to exercise ordinary care;  
23 b. Failing to provide safe sleeping arrangements  
24 and/or safe conditions for Krysta Necole Pinson;

- c. Having bunk bed designs that did not comply with national standards for protection of children up to 15 years old,;
- d. Having bunk beds that were not suitable for school age users because of the hazards due to design issues;
- e. Making modifications to bunk beds by changing mattress size resulting in increase in the risk to user of falling from upper bunks;
- f. Having bunk beds that lacked required labeling to indicate proper mattress size that led to wrong mattress being used on bunk;
- g. Having bunks with modifications of mattress that increased danger to user of slipping and sliding from upper bunk;
- h. Failure to conduct an inspection to assure bunk beds were suitable and safe for this age user;
- i. Failure to conduct an inspection to assure bunk beds complied with national standards;
- j. Failure to restrict, limit, warn or instruct on the use of certain types of sleeping bags for the upper bunks;

- k. Failure to protect and/or warn invitees and/or licensees from reasonably foreseeable risks of harm; and/or
- l. Failure to warn and/or correct a latent dangerous condition on the premises.

## VI. Damages

6.1 That as a direct, proximate, and foreseeable result of Respondent, Skamania County's negligence as alleged in this Claim, it has been necessary for The Estate of Krysta Necole Pinson, Krysta Necole Pinson, and/or her parents, Britton T. Pinson and Beth E. Pinson to incur medical attention and expenses, and to incur travel and other expenses in securing medical treatment. The Estate of Krysta Necole Pinson, Krysta Necole Pinson, and/or her parents, Britton T. Pinson and Beth E. Pinson, have incurred medical bills in the amount of \$16,896.06, as a proximate result of the negligence of Skamania County, as earlier set out in this Tort Claim Notice.

6.2 That as a direct, proximate, and foreseeable result of Respondent, Skamania County's negligence as alleged in

1 this Claim, Krysta Necole Pinson has incurred physical  
2 handicap and/or disability in connection with her usual  
3 activities, and has suffered injury, pain, suffering,  
4 disfigurement, and an impairment of ability to enjoy  
5 life. By reason of the matters alleged in this Tort  
6 Claim Notice, Krysta Necole Pinson and/or The Estate of  
7 Krysta Necole Pinson has suffered general damages in  
8 the amount of \$75,000.00;  
9

10  
11  
12 6.3 The Estate of Krysta Necole Pinson, Krysta Necole  
13 Pinson, and/or her parents, Britton T. Pinson and Beth  
14 E. Pinson, have incurred medical bills in the amount of  
15 \$16,896.06, as a proximate result of the negligence of  
16 Skamania County, as earlier set out in this Tort Claim  
17 Notice.  
18

19 6.4 Britton T. Pinson and Beth E. Pinson, as parents of  
20 Krysta Necole Pinson, have suffered damages under RCW  
21 4.24.010. By reason of the matters alleged in this Tort  
22 Claim Notice, Britton T. Pinson has suffered damages in  
23 an amount of \$10,000.00 and Beth E. Pinson has suffered  
24 damages in an amount of \$10,000.00;

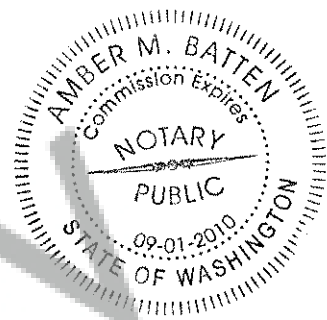

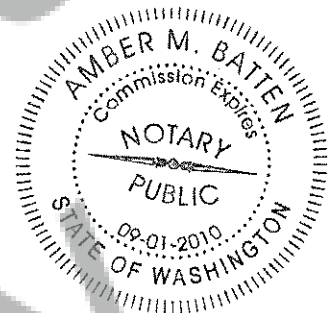
