NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SURVEY AND MONUMENT THE EXTERIOR BOUNDARY OF THAT TRACT OF LAND DESCRIBED IN BOOK 72, PAGE 129 OF SKAMANIA COUNTY RECORDS. THE EXTERIOR OF SECTION 18 WAS COMPUTED BASED ON D.N.R. LAND CORNER RECORDS. BOOK 3/8 AT VARIES PAGES. TWO SURVEY PERFORMED IN THE NORTHEAST QUARTER OF SECTION 18 WERE USED. ONE PERFORMED BY TERRA SURVEYING RECORDED IN BOOK 1 OF SURVEYS PAGE 249. THE SECOND PERFORMED BY LONGVIEW FIBER RECORDED IN BOOK 3 OF SURVEYS PAGE 126. A CLOSED LOOP TRAVERSE WAS RAN FROM A D.N.R. BRASS CAP LOCATED AT THE EAST QUARTER CORNER OF SECTION 18 TO A 5/8" IRON ROD WITH A 2" ALUMINUM CAP SET FOR THE CENTER OF SECTION. THE BONNEVILLE POWER ADMINISTRATION MONUMENT UNDER THE NORTHERLY TOWER AND FILED TIES ALONG THE SOUTHERLY TOWERS WHICH AGREED WITH THE BONNEVILLE POWER ADMINISTRATION McNARY-ROSS RIGHT OF WAY MAP. DEED DISTANCE WERE THEN APPLIED AND MONUMENTS SET.

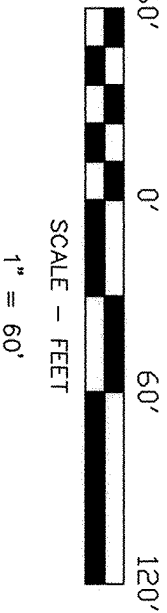

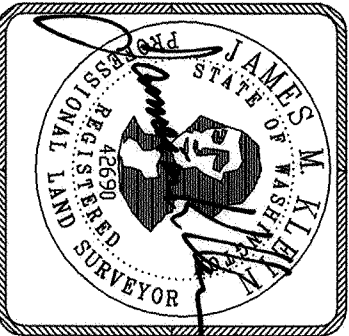
PROCEDURES

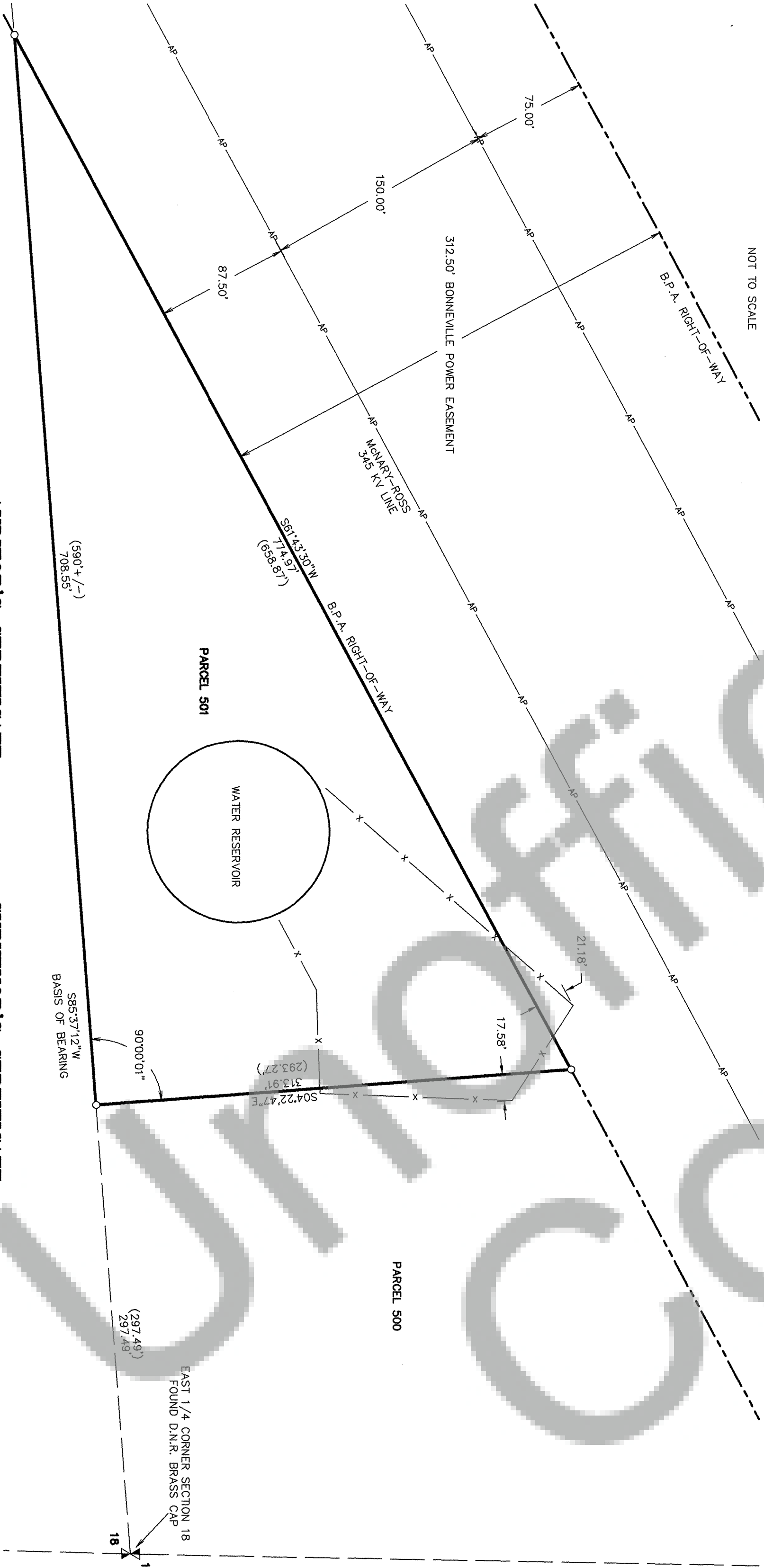
