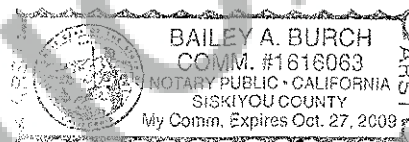

LEGAL DESCRIPTION FOR FRUIT GROWERS SUPPLY COMPANY

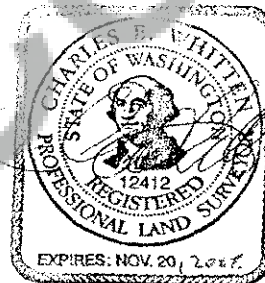
TRACT 8 (20.15 ACRES; BLA IN 2008):
