septic tank with a new septic tank that will still be located south of the house, and to replace the existing drainfield at the southeast corner of the house with a new drainfield west of the house. It was originally proposed to use the existing septic system however upon inspection by the Skamania County Health Department and Debra Brown your septic engineer it has been determined that the existing septic system must be abandoned due to damage caused by the fire.


