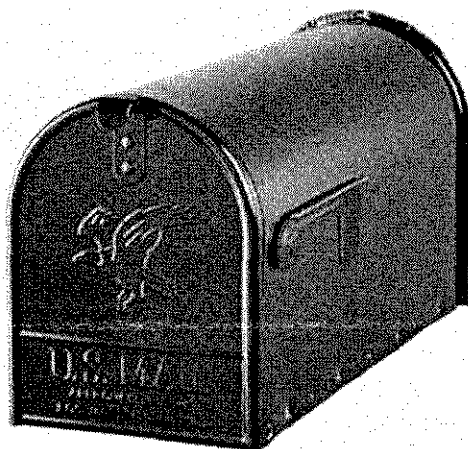
I don't need any money for the labor as I will do the work myself. I have enclosed a web page from Home Depot that shows you the same size box we have and its cost.

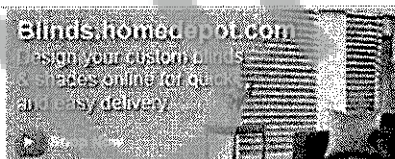
