- 1. The terms of the Note and the Security Instrument, including any addenda and riders, are amended and modified as follows:
 - My regular monthly principal and interest payment under the Note shall commence on SEPTEMBER 1, 2008
 - Under the terms of the Rate Improvement Rider: Commencing AUGUST 1, 2008 the interest on my Note shall be 6.8750 percent per annum and my regular monthly principal and interest payment under the Note shall be \$2,509.47.
