NOTICE HEREBY IS GIVEN that the undersigned locators, each a citizen of the United States or one who has declared an intention to become such, have discovered on Oct. 25, 2008, a vein or lode of locatable mineral-bearing rock in place upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and in accordance with the laws of the United States and of the State of Washington, have located and do hereby locate a claim upon such vein or lode by posting this notice of such discovery and location on a substantial post or monument at the point of discovery. The name of the claim is: Rock of Ages #5 Claim, further described* as follows:

Commencing at a post marked No. 1;
then 1,500 feet in a North direction to a corner post marked No. 2,
then 600 feet in a West direction to a corner post marked No. 3,
then 1,500 feet in a South direction to a corner post marked No. 4,
then 600 feet in a East direction to that corner post marked No. 1.
