This amendment is in regards to the outbuilding height, now listed as a total of 18 ft. from the top of the concrete slab to the finished peak of the roof.

I would like to increase the depth of the truss that sits on the top plate so that we could put a full 12 inches of insulation above the wall. As you can see from the attached drawings the first truss listed can't get very much insulation above the wall.


We would also like to add 11 inches to the wall height. The total we are asking for is 19 ft. 10 inches instead of the 18ft., which is a total increase of 1ft. and 10 inches more. 


