ELIZABETH L. CUMMINGS REVOCABLE LIVING TRUST AGREEMENT

I, ELIZABETH L. CUMMINGS, of Vancouver, Washington, declare that this is the Second Amendment to the Elizabeth L. Cummings Revocable Living Trust Agreement executed on July 18, 1996, as amended by the First Amendment dated September 1, 1998.

Pursuant to Article 1, paragraph 1.6, of the Trust Agreement referred to above, Trustor hereby amends such Trust Agreement as follows:

ARTICLE 5

- 1. The following amendments and additions are made to Article 5.1 of the Trust Agreement:
 - A. Paragraph (e) is renumbered as paragraph (f).
 - B. A new paragraph (e) is inserted as follows:

The sum of twenty five thousand and no/100 dollars (\$25,000.00) and any and all interest in the real property under the Term Special Use Permit for Recreation Residences located at the Government Mineral Springs Summer Home Tract in Skamania County, Washington, as more fully described on Exhibit "B" to Schedule A of the Trust Agreement ("Cabin") shall be distributed as follows:

To my children or the survivor of them, as Trustees in Trust, for the benefit of my grandchildren: (1) Randy Todd Cummings, (2) Jennifer Lyn Cummings, (3) Marni Kay Ford Wagner, and (4) Kristi Renee Ford Bulleit, or if any of my grandchildren predecease me then by right of representation for that grandchild's descendants who survive me. The Trustees shall manage the Cabin for the benefit of the named trust beneficiaries until the happening of one of the following events:
