Your request for a letter amendment states you request to increase your previously approved replacement pump house (10' X 20') by an additional 200 square feet with a foot print of 20' X 20'.

The Condition of Approval shall be amended to read:

2) All developments shall be consistent with the enclosed site plan, unless modified by the following conditions of approval. If modified, the site plan shall be consistent with the conditions of approval. The modified accessory building shall have a foot print of 20' X 20'.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The proposed request constitutes a minor change; therefore, the original decision shall be amended to the temporary use of an accessory building.

All of the original conditions in the Administrative Decision are still valid and shall be complied with. As a reminder, this letter amendment needs to be recorded at the County Auditor's office, as does your Administrative Decision prior to the sign-off any Building Permits.
