
SURVEY in NW¼SE¼ Sec. 36, T3N, R7E, W.M. Lots 1-5, Block 5, ROSELAWN EXTENSION (vacated), in the City of Stevenson

Tax Parcel No. 03-07-36-2-4-1201-00

NARRATIVE: A closed loop with radial ties to monuments of record was traversed about the entire parcel. The purpose of this survey is to create and monument a two-lot short plat. In Book V, Page 177 of Deeds (1927), the Grantor reserved a 20-foot strip for road purposes, presumably for the parcel adjacent to the North, which was never constructed. This action did not create an easement. No evidence was found to indicate that Lot 6 has any written right to use this strip for access, although a prescriptive right from continued use may exist. Based on Reference 3, the existing driveway as measured on the Southerly line of this parcel has moved some 20 feet Westerly since 2001.

TRAVERSE STATEMENT: Fieldwork was conducted during the period September 9, 2008 -January 26, 2009. Equipment used: Topcon GPT-3003LW total station last inspected in January of 2008 by PPI, Portland, OR.
