SHAKED PARKING AGREEMENT
This SHARED PARKING AGREEMENT ("Agreement") is entered into and effective on
June 17th , 20 00, by and between SKAMANIA COUNTY (Applicant &
Co-Applicant), and the City of Stevenson.
RECITALS
WHEREAS, pursuant to sections 17.42.060 and 17.42.070 of the Stevenson Municipal Code, the
City of Stevenson specifies criteria which must be met in order to utilize shared parking
agreements to satisfy on-site parking requirements.
NOW, THEREFORE, in consideration of the recitals and mutual obligations of the parties as
herein expressed, <u>SKAMANIA COUNTY</u> and the City of Stevenson agree as follows:
1. THE SKAMANIA COUNTY FAIRGROUNDS a use of the property located at
710 SW Rock Creek Drive , agrees to provide THE EXPANDED ROCK CREEK
COMMUNITY SERVICES CENTER , another use of the property located at 710 SW
Rock Creek Drive , with the right to the use of (19) parking spaces as shown on Exhibit A
to this Agreement.

- 2. The parking spaces referred to in this Agreement have been determined to conform to current City of Stevenson standards for parking spaces, and the parties agree to maintain the parking spaces to meet those standards. This determination was made by the Planning Commission based on the following conditions:
 - 2.a. When the expansion of Rock Creek Community Services Center is completed, the County shall abandon and remove the building currently used as the Senior Services Office. The seven (7) spaces formerly utilized by the Senior Services Office shall then be dedicated to the Rock Creek Community Services Center.
 - 2.b. Special events at the Skamania County Fairgrounds shall be scheduled and/or sited to avoid utilizing the nineteen (19) shared spaces during the hours of normal business operation for the Rock Creek Community Services Center.
 - 2.c. If special events at the Skamania County Fairgrounds require the use of the nineteen (19) shared spaces, the County shall not utilize the Auditorium of the Rock Creek Community Services Center during the hours of normal business operation for the Rock Creek Community Services Center.
 - 2.d. The County shall add signage which directs visitors to, and identifies the location of, the shared parking spaces.
 - 2.e. All parking spaces shall be striped and shall meet the size requirements of the Stevenson Municipal Code.
- 3. The Parties understand and agree that if for any reason the shared parking spaces are no longer available for use by <u>THE EXPANDED ROCK CREEK COMMUNITY SERVICES</u>

 CENTER or if for any reason the conditions described herein are violated, <u>SKAMANIA COUNTY</u> will be in violation of the City of Stevenson Zoning Code requirements. If the shared parking spaces are no longer available, Applicant will be required to reduce or cease operation and use of the property at Applicant's address to an intensity approved by the City in order to bring the property into conformance with the Zoning Code requirements for parking. Applicant agrees to waive any right to contest enforcement of the City's Zoning Code in this manner should this circumstance arise.

Although the Applicant may have recourse against the Party supplying shared parking spaces for breach of this Agreement, in no circumstance shall the City be obligated by this agreement to remedy such breach. The Parties acknowledge that the sole recourse for the City if this Agreement is breached is against the Applicant in a manner as specified in this paragraph, and the City may invoke any remedy provided for in the Zoning Code to enforce such violation against the Applicant.

4. The provisions and conditions of this Agreement shall run with the land for those properties referenced in paragraph 1 of this document and be enforceable against successors in interest and assigns of the signing parties.

5. Title to and the right to use the lots upon which the parking is to be provided will be subservient to the title to the property where the primary use it serves is situated.

6. The property or portion thereof on which the parking spaces are located will not be made subject to any other covenant or contract for use which interferes with the parking use, without prior written consent of the City.

7. This Agreement is in perpetuity and can only be terminated if replacement parking has been approved by the City's Planning Director and written notice of termination of this agreement has been provided to the other party at least sixty (60) days prior to the termination date.

8. This Agreement shall be kept on file in the City of Stevenson City Hall under the Project Number: PAR2009-01 and shall be recorded on the titles of those properties referenced in paragraph 1 of this document.


