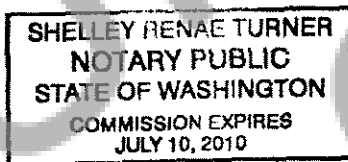

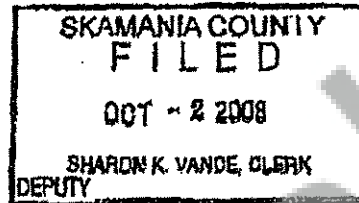

1 THIS MATTER having come on regularly for hearing; it appearing to the Court that the  
 2 sum of \$49,778.07 (original judgment plus that awarded in Court of Appeals No. 32153-0-II) is  
 3 currently due and owing to defendants from plaintiff; it further appearing that the sum of  
 4 \$50,000.00 is currently being held by the Clerk as supersedeas; it further appearing that the Court of  
 5 Appeals has awarded further attorney's fees in favor of defendants and against plaintiff and  
 6 intervenors Weiss and Miller; and good cause appearing therefor:

8 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

9 1. The Clerk is directed to disburse all sums currently within the registry of the Court  
 10 to defendants. Judgment is hereby entered against plaintiff and intervenors jointly and severally as  
 11 follows:

- 13 a. Attorney's fees & costs — \$28,448.79 (as awarded in Court of  
 Appeals No. 35536-1-II.)  
 14 b. Interest — \$236.37 representing accrued interest in the amount of  
 15 \$458.30 less \$221.93 of the balance left after satisfaction of all  
 16 claims by defendants against plaintiff only.

17 2. All judgments previously entered against plaintiff only are hereby deemed satisfied  
 18 in full. Nothing in this paragraph shall affect the judgments stated in paragraphs 1, 3, and 4 of this  
 19 Supplemental Judgment.

20 3. Additionally, defendants are entitled to judgment against plaintiff and intervenors,  
 21 jointly and severally for attorney's fees in the amount of \$425.00..
