I hereby request removal of my land from Forest Land Designation in accordance with Chapter

The land was designated as forestland on 7/1/1975 and the approved application was filed under County Auditors Record No. Book F / Page 9.

I declare that I am aware of the liability for removal from designation to the following extent:

1. Cost of filing the Request for Removal of the land with the County Auditor; and
2. Payment of Compensating Tax equal to the difference between the amount of the assessed valuation on such land as forest land and the amount of the new assessed valuation of the land, multiplied by the dollar rate of the last levy extended against the land, multiplied by the number of years (not to exceed 9 years -plus the current tax year) the land was assessed as forest land.

I understand that the Compensating Tax and applicable Interest becomes a lien on the land until fully satisfied.
