Protective Covenants, Conditions and Restrictions Affecting Lot 2 of Verley Short Plat, Tract B of Ostermann Short Plat Parcel No. 03-10-02-0-0-0300 & 03-10-02-0-0-0304-00

- 1. Dwellings shall be limited to on-site built only. All structures shall be built on concrete foundations. Roofs shall be of non-reflective material.
- 2. No dwelling shall be constructed containing less than 1200 square feet of living area exclusive of porches, garages and decks.
- Any construction of buildings shall be completed in a timely manner not to exceed 12 months for the exterior finish.
- 4. No radio towers, wind generators or similar types of tall structures are to be erected.
- 5. Unlicensed automobiles, debris, or other accumulated junk shall not be permitted to be stored on subject property.
- 6. No animals, livestock or poultry of any kind for a commercial nature shall be raised, bred or kept on any lot. Provided, however, that horses, dogs and cats or other usual household pets may be kept upon the premises for non-commercial purposes and for the owner's personal use.

The purpose of these restrictions is to ensure the use of the property for attractive residential purposes only, to prevent nuisances, to prevent impairment to the attractiveness of the property, to protect each owner of said property against improper use of said property as may depreciate the value of property, and to maintain the desired tone of the community and thereby to secure to each property owner the full benefit and enjoyment of their property, with no greater restriction on the free and undisturbed use of property than is necessary to ensure the same advantages to other property owners.
