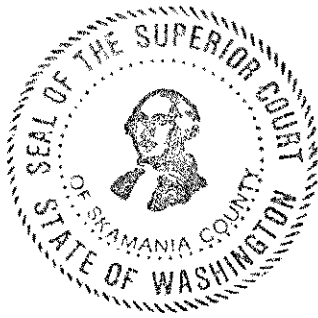

ORDERED that Plaintiff have judgment against the Defendants CORY D. SCOTT & ELIZABETH SCOTT as follows:


