

TRAVERSE & ACCURACY STATEMENT

A POINT TO POINT TRAVERSE FOR THE PARCEL SHOWN WAS MADE WITH A FIVE-SECOND TOTAL STATION AND RELATED MEASURING EQUIPMENT, OF WHICH MEET STATE STANDARDS (WAC 332-130-090,-100) AT THE TIME OF THIS SURVEY. THE MONUMENTS WERE FOUND TO BE WITHIN ACCEPTABLE TOLERANCES OF THEIR CALCULATED POSITION, UNLESS OTHERWISE NOTED ON THIS SURVEY.

SURVEY NARRATIVE

THIS SURVEY FOUND THE REF. 1 SURVEY MONUMENTS TO BE WITHIN ACCEPTABLE TOLERANCES. THE LOCATION OF SET MONUMENTS FOR TAX LOT 700 WERE CALCULATED AND SET BASED UPON THE REF. 1 CALCULATED POSITIONS.

THE SE MONUMENT OF TAX LOT 600 MAY BE BURIED IN THE ROOTS OF A 24' DOUGLAS FIR TREE (NOT TIED)

A 5/8" REBAR FROM AN UN-RECORDED SURVEY WAS FOUND AND ACCEPTED FOR THE POSITION OF THE SOUTHWEST CORNER OF TAX LOT 700.





