Dear Mr. & Mrs. Carter,

I requested a meeting with affected departments of Skamania County this morning to discuss the locations of the buildings that have been shown to be encroaching on County Right of Way in the vicinity of 2391 Wind River Road, Carson, Washington.

It was determined that the following will be required in order to retain the buildings at their current location:

1. You will need to apply for a Special Right of Way Use Permit for the structures currently in the R/W. (application enclosed). Once the permit is issued, it will be up to the landowner to have this document recorded to the property deed and provide this department with a copy of the property deed showing compliance. Skamania County will cover all recording fee costs.
2. No new structures will be allowed under this permit authority.
3. Apply for building permit(s) for any unpermitted structure lying within the R/W, (application enclosed).
4. Comply with Building Code requirements as set by the building permit.

The Special Right of Way Use Permit is contingent on you completing these requirements.

Any structure over 200 sq. feet must be permitted according to Skamania County Code, Title 15, and Section 15.08.030.
