PROMISSORY NOTE

\$ 25,738.25 U. S. Dollars

FOR VALUE RECEIVED, Ron Schneider and Dawn White-Schneider (Borrower) hereby promise to pay unto Skamania County Economic Development Council (Lender), or order the principal sum of Twenty-five Thousand Seven Hundred Thirty-eight Dollars and Twenty-five Cents (\$25,738.25) with interest from the date of this Note, until paid, at the rate of 6.25 percent per annum. Principal and interest shall be payable to the Skamania County Economic Development Council in Sixty (60) consecutive installments of Four hundred Twenty-eight Dollars and Ninty-seven Cents (\$428.97), including interest, beginning August 2, 2010, and continuing on the fifteenth day of each month thereafter until paid, except that if not sooner paid, this Note shall be due and payable in full on August 2, 2015.

This note may be prepaid in whole or in part at any time without penalty. This Note is not assumable without express written consent of Lender, which consent is not to be unreasonably withheld.

The Borrower agrees to pay a late charge of 5 % of the amount of any payment that is ten (10) or more days past due.

In the event of default, the Borrower shall be responsible for all costs of collection, including but not limited to attorney's fees. If more than one Borrower, all shall be jointly and severally liable, and notice to one shall constitute notice to all.
