This matter having come on before the court upon Plaintiff's Motion for Order of Default and Partial Default Judgment; and the Court having considered the Plaintiff's Motion for Order of Default and Partial Default Judgment, the Declaration of Tom Paulo; and the Defendants appearing not, and the Plaintiff having complied with the Servicemembers' Civil Relief Act, it is hereby ENTERS THE FOLLOWING FINDINGS:
