The Lode Mining Claim is DESCRIBED as being situated in an unknown Mining District, Lewis and Skamania Counties, State of Washington.

The boundaries of the claim are marked by four substantial monuments, one at each corner of the claim. Said monuments consist of trees so marked at least 8 inches in diameter, rock cairns at least three feet in height, or 4x4 nominal posts at least 3 feet in height above the ground. Further described as follows:

Beginning at the NE corner (Cor. No. 1), thence 1500 feet south to the SE Corner (Cor. No. 2), thence 600 feet west to the SW Corner (Cor. No. 3), thence 1500 feet north to the NW Corner (Cor. No. 4), thence 600 feet east to the Point of Beginning.

The NOTICE OF LOCATION was posted at a conspicuous place at the point of discovery (monument of location), on the centerline of the claim 1490 feet from the northerly end line and 10 feet from the southerly end line.

To tie this claim to the Public Survey, begin at the SW corner, Section 32, Township 11 North, Range 6 East, Willamette Meridian, bear west, 6000 feet, and north, 750 feet to the northeast corner, post No. 1 of this claim. The claim is located in the following quarter sections:


