The Lode Mining Claim is DESCRIBED as being situated in an unknown Mining District, Skamania County, State of Washington.

The boundaries of the claim are marked by four substantial monuments, one at each corner of the claim. Said monuments consist of trees so marked at least 8 inches in diameter, rock cairns at least three feet in height, or 4x4 nominal posts at least 3 feet in height above the ground. Further described as follows:

Beginning at the NE corner (Cor. No. 1), thence 600 feet south to the SE Corner (Cor. No. 2), thence 1500 feet west to the SW Corner (Cor. No. 3), thence 600 feet north to the NW Corner (Cor. No. 4), thence 1500 feet east to the Point of Beginning.
