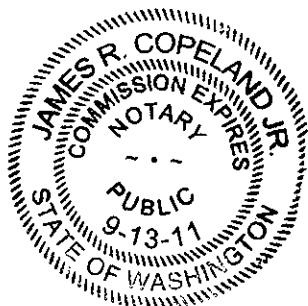


EXHIBIT 'A'

Lots 1, 2, 3 & 4, Block 2, Cascade Addition, according to the plat thereof, recorded in Book A of Plats, Page 62, records of Skamania County, Washington.

Except that portion of the said Lot 4 described as follows:

Beginning at the most Easterly corner of the said Lot 4; Thence North  $50^{\circ}58'$  West 33.4 feet; Thence in a Southwesterly direction 50.6 feet to a point on the Southerly line of the said Lot 4 distant 55.2 feet from the Point of Beginning; Thence along said Southerly line 55.2 feet to the Point of Beginning.

Also Excepting that portion of Lots 1, 2 and 3, Block 2, Cascade Addition, according to the plat thereof, recorded in Book A of Plats, Page 62, records of Skamania County, Washington, particularly described as follows:
