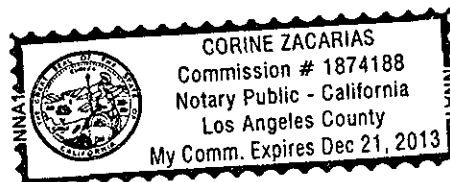


Exhibit A
