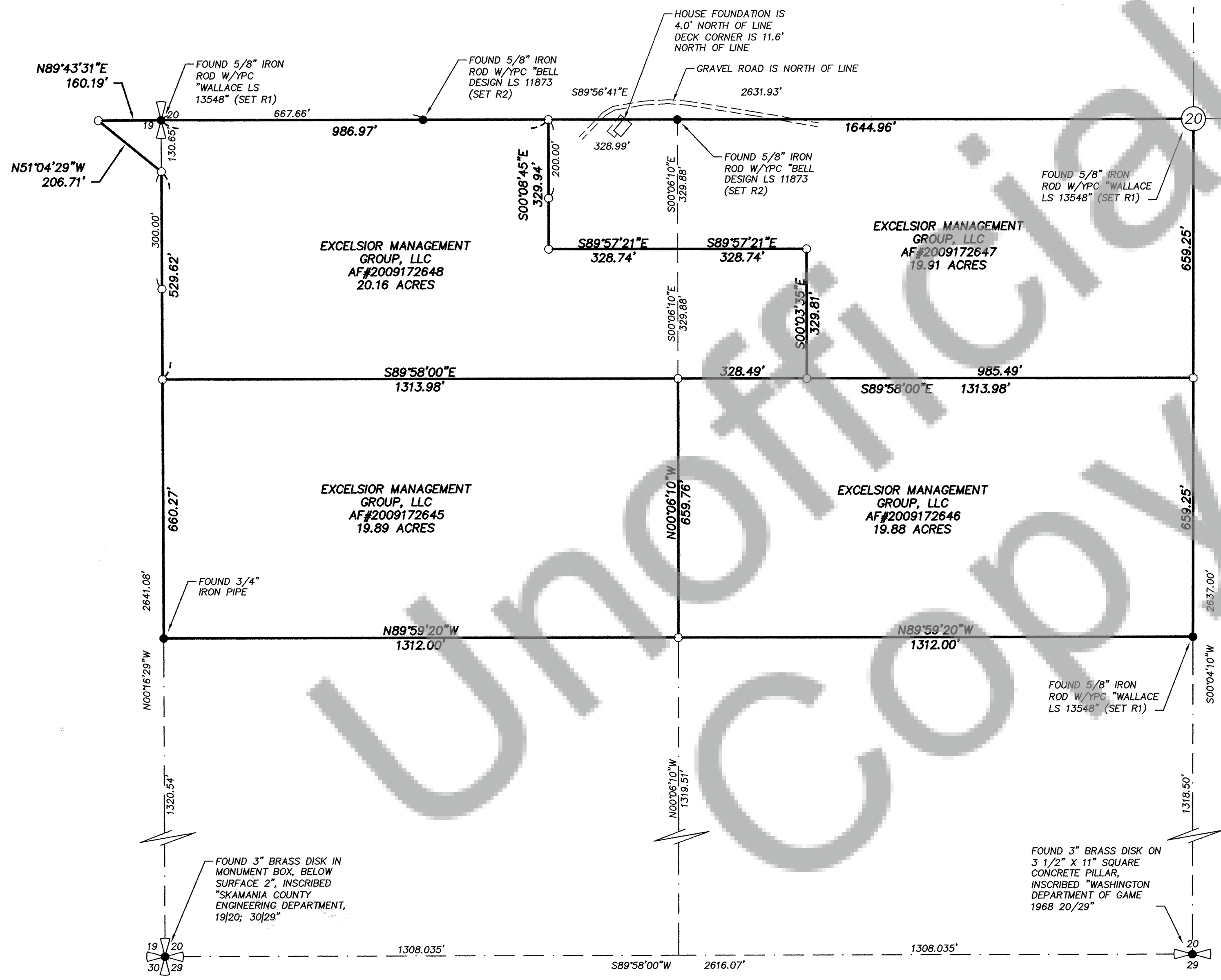
THE PURPOSE FOR THIS SURVEY WAS TO DEFINE AND MONUMENT THE EXCELSIOR MANAGEMENT GROUP, LLC PARCELS AS DEFINED BY AUDITOR'S FILE NUMBERS 2009172645, 2009172646, 2009172647 AND 2009172648, SKAMANIA COUNTY DEED RECORDS.

THE SUBJECT PARCELS ARE DEFINED AS SECTIONAL SUBDIVISIONS OF THE SOUTHWEST 1/4 OF SECTION 20, TOWNSHIP 2 NORTH, RANGE 5 EAST, WILLAMETTE MERIDIAN.

THE MONUMENTS MARKING THE SOUTHWEST CORNER, THE SOUTH 1/4 CORNER AND THE WEST 1/4 CORNER OF THE SECTION WERE FOUND AND HELD AS SHOWN. THE CENTER OF SECTION WAS ESTABLISHED IN 1977 BY SURVEY REFERENCED HEREON AS R1, AND HAS BEEN HELD BY SUBSEQUENT ADJACENT SURVEYS. THIS MONUMENT WAS ALSO FOUND AND HELD AS SHOWN.

EXISTING MONUMENTS OF RECORD WERE FOUND TO FIT WITHIN ACCEPTABLE TOLERANCE AT THE SOUTHEAST AND SOUTHWEST CORNERS OF THE ENTIRE SITE. THE REMAINING MONUMENTS WERE SET AS SHOWN FOLLOWING THE DEED DICTATES.

THE BEARINGS WERE BASED ALONG THE WEST LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 20 PURSUANT TO SURVEY R1.
