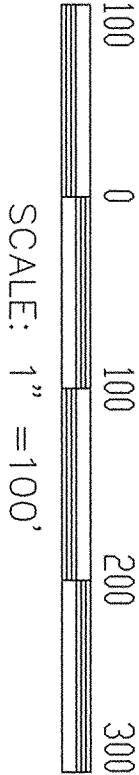


RECORD OF SURVEY

NARRATIVE, EQUIPMENT USED,  
METHOD OF SURVEY & BASIS OF BEARINGS

THE PURPOSE OF THIS SURVEY WAS TO MONUMENT A PORTION OF THE CENTERLINE OF HOT SPRINGS AVENUE, AS SHOWN. THIS PORTION OF THE ROAD HAS BEEN RECENTLY RECONSTRUCTED AND OUR FIRM PERFORMED THE CONSTRUCTION SURVEYING FOR THE REBUILDING OF THIS SECTION OF THE ROAD. OUR BASIS OF BEARING FOR THE CONSTRUCTION SURVEYING AND THE ULTIMATE SETTING OF THE HORIZONTAL CONTROL WAS DERIVED BY USING AN ELECTRONIC DRAWING FILE SUPPLIED BY THE FIRM OF SKILLINGS CONNOLLY OF LACEY, WASHINGTON WHICH SHOWED BOTH HORIZONTAL AND VERTICAL CONTROL USED IN THE PREVIOUS 10-YEAR SPAN DURING THE DESIGN OF SAID ROAD. A RANDOM FIELD TRAVERSE WAS RUN TYING IN THE FOUND ORIGINAL CONTROL USING A LETTZ SET 48 TOTAL STATION. ALL CENTERLINE COORDINATES SHOWN HEREON WERE SUPPLIED BY SKAMANIA COUNTY ENGINEERING DEPARTMENT. THE DRAWING "BASE" IS A PORTION OF THE AFORESAID ELECTRONIC DRAWING SUPPLIED BY "SKILLINGS CONNOLLY" AND IS BEING USED FOR REFERENCE ONLY. THE TIES TO THE ONE-QUARTER CORNER AND MONUMENT NO. 2738-D WERE NOT FIELD MEASURED BUT WERE CALCULATED PER THE COORDINATES FROM THE AFORESAID CONTROL DRAWING.

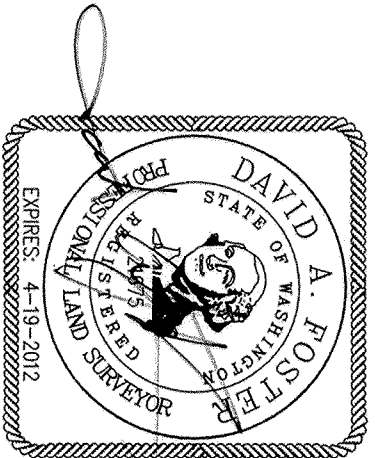
