Anyone having any objections to the sale on any grounds whatsoever will be afforded an opportunity to be heard as to those objections if they bring a lawsuit to restrain the sale pursuant to RCW 61.24.130. Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's sale.

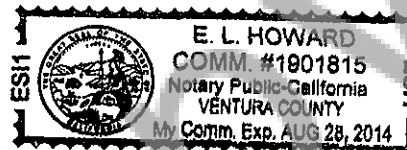

A tract of land located in the North half of the Section 28, Township 2 North, Range 5 East of the Willamette Meridian, Clark County, Washington, described as follows:
