Thence S 01°39'02" W, along the West line of said Lot 3 a distance of 201.83 feet to the South line of the existing Waterline Easement as shown in Lot 2 of said Short Plat;  
Thence N 64°25'10" W, along the South line of said existing Waterline Easement 10.94 feet;

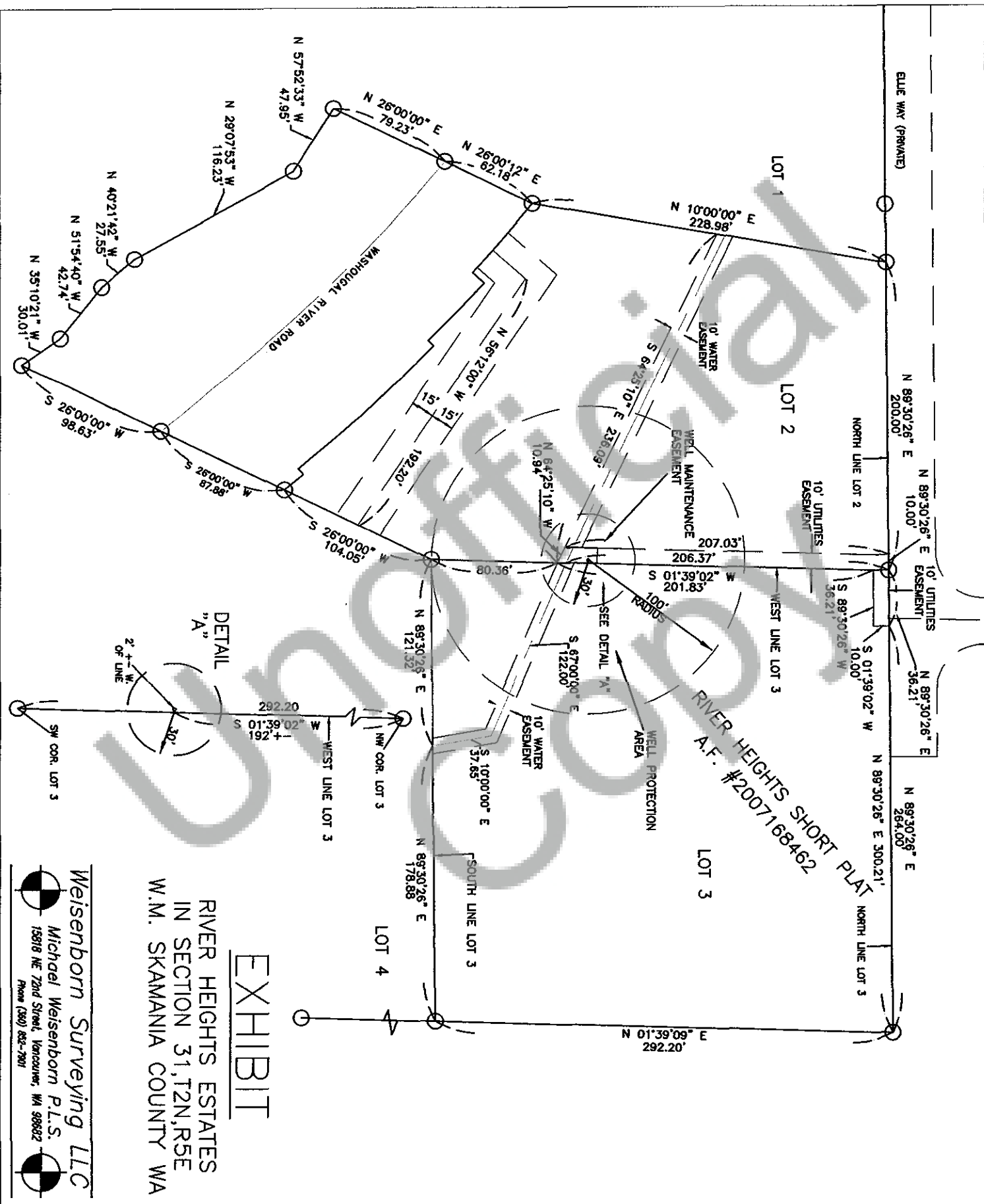




