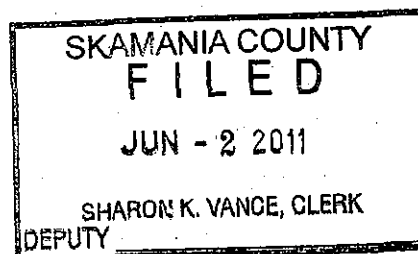

ORDERED, ADJUDGED, and DECREED that the Defendant(s) is/are hereby in default.


