A tract of land located in the southwest quarter of the southwest quarter of Section 26, Township 4 North, Range 7 East, of the Willamette Meridian, in the County of Skamania and State of Washington being more particularly described as follows:

Beginning at the southwest corner of said Section 26; thence along the south line of the southwest quarter of the southwest quarter of said Section 26, South $89^{\circ}16'56''$ East, a distance of 518.47 feet; thence North $00^{\circ}11'28''$ East, a distance of 607.79 feet to the thread of the stream of Martha Creek; thence northwesterly, westerly and southwesterly, along said thread to the west line of the southwest quarter of the southwest quarter of said Section 26; thence along said west line, South $00^{\circ}11'28''$ West, a distance of 499.77 feet to the point of beginning.
