ASSIGNMENT OF LOAN AGREEMENT

RECITALS

This Assignment Agreement is made and entered into by and among the State of Washington Department of Community, Trade and Economic Development (the "Department"), the Skamania County Economic Development Council (the "SCEDC") and Angus Ruck DBA Columbia Gorge Riverside Lodge (the "Borrower") and pertains to Contract Number F01-75100-340, as provided in Section 12 of the Contract.

WHEREAS the Department entered into an agreement with the Borrower on April 1, 2001 to loan the Borrower a total of \$293,000 in Columbia River Gorge Economic Development Program resources to purchase an 8-unit lodging establishment to operate as the Columbia Gorge Riverside Lodge and to assist with working capital needs;

WHEREAS the Borrower's payments of principal and interest are current with a balance owing of \$ 241,215.26;

WHEREAS the Department has entered into an agreement with the SCEDC to administer the Columbia River Gorge Economic Development Program and the Washington Investment Fund in support of the Washington Investment Board consistent with the goals set forth in the original Washington Economic Vitality Plan in 1991, and subsequent plan updates in 1999 and 2004; and

WHEREAS the assignment of the loan agreement is a requirement to successfully transition the program and the fund to full local management and control.

NOW, THEREFORE in consideration of the covenants, conditions, performances, and promises hereinafter contained, the parties hereto agree as follows:

AGREEMENT

The Department fully and irrevocably assigns to SCEDC, the Department's interests in the loan agreement contained in Contract Number F01-75100-340 between Angus Ruck, dba Columbia Gorge Riverside Lodge, and the Department, and in all Loan Documents related thereto. Loan Documents include all documents required by the Department to make and close, and administer, the loans that are subject to contract number F01-75100-340, including but not limited to the Department promissory notes, security agreements, financing statements, and assignment of assets. Any reference in the loan agreement to the "Department" shall now mean the "SCEDC."

By accepting this assignment, SCEDC agrees to accept all rights, responsibilities, costs and financial liability formerly held by the Department in relation to Contract Number F01-75100-340, including collecting and disbursing funds, monitoring and reporting Borrower's performance and outcomes, addressing any problems that might arise regarding the loan agreement and, in the event of default, pursuing legal remedies.
