## FINDINGS AND ORDER

This matter having come on before the court upon Plaintiff's Motion for Order of Default and Partial Default Judgment; and the Court having considered the Plaintiff's Motion for Order of Default and Partial Default Judgment, the Declaration of Mark Provolt; and the Defendant appearing not, and the Plaintiff having complied with the Servicemembers' Civil Relief Act, it is hereby ENTERS THE FOLLOWING FINDINGS:

1. Pursuant to Civil Rule 54(b), an express determination is made that there is no just reason for delay on entry of the Judgment on the claim for monetary damages and as a result, an express direction is made for the entry of judgment as is ordered herein.

Based on the foregoing Findings, it is hereby ORDERED AS FOLLOWS:

- 2. Defendant's claims, if any, are dismissed with prejudice.
- 3. Plaintiff's Motion for Order of Default and Partial Default Judgment is granted.
